A federal judge on Monday dismissed a lawsuit filed by a coalition of 12 states and the District of Columbia challenging President Trump's controversial decision to end the Obama-era Deferred Action for Childhood Arrivals (DACA) program. In ruling, Judge John Bates dismissed most of the plaintiffs' claims, including those against the federal government and its agencies and those based on the separation of powers. He upheld some claims against the states that the government proposed to deport people who had come to the United States as children. The government had argued that DACA, which was enacted in 2012, was unconstitutional because it lacked proper congressional authorization. Bates' ruling found that DACA was not enacted in violation of the Constitution. The judge also determined that the separation of powers didn't necessarily prevent the administration from ending DACA. The judge did, however, rule that the Justice Department must provide written justification for its reasoning behind the decision. "Our unanimous conclusion is this: DACA was never authorized by statute. An unlawful program cannot give rise to an individual obligation," Bates wrote in his 74-page ruling. In his decision, Bates also recognized the concerns of the states and the District of Columbia that the Trump administration's decision to end DACA could lead to "massive and irreparable injury, as a matter of law and fact." Bates wrote that the government would not likely be able to show that DACA's cancellation "would not work irreparable injury, as a matter of law and fact." Bates wrote that the federal government seemed to argue that a "vital and public interest" of the United States and the states is "safe and secure borders."
